

CONDITIONS FOR SPORTS EVENT „PREDATOR RACE“

- These conditions edit legal relationship between contestant who is competing in PREDATOR RACE (incl. Predator Race, Predator Run, Predator Challenge, Predator Workout, Predator Park, Predator Gym and Predator junior) and organizer of this race. Also other conditions for contestant so they can participate in this event.
- With his own signature on the last page contestant confirms that he is competing by his own and voluntary will and is participating by his own choice and on his own responsibility. Contestant also takes note that organizer of this event only participate as an organizer and contestant is participating on this race on his own risk without any help of an organizer.
- Contestant also understands that PREDATOR RACE is mentally and physically challenging and that he needs to be in a good shape mentally and physically because it's an endurance race in natural terrain and with a lots of obstacles and can be unpredictable due to the weather and natural conditions.
- With all being said above contestant is aware that he can be injured or bodily harm (drowning, sprained or dislocated limb, torn ligaments, broken limbs or any other body exhaustion). Organizer recommends to all contestants to consider their ability to participate on the race and don't recommend to start if they are not feeling prepared.
- Every contestant needs to follow any instructions from the organizer, maintain personal discipline and principles of sporting ethics to avoid any injuries of his own or the other contestants. If he violates any competition conditions he can be disqualified without any compensation.
- Contestant fully and comprehensibly understands its legal negotiations and agrees to take over all the risk that may arise from their participation in the race, especially in form of serious damage to health that can develop among other things, at individual obstacles on the track, which may under certain circumstances unexpectedly release which can entail the creation of a serious health harm. Contestant agrees with all the risks of tracks, known or unknown, even if they may occur randomly without predictable situations.
- Contestant declares that in the context of preventing any harm in the event if he sees any unusual or some risk that he would personally make all possible efforts to ensure that competition can take place unhindered and he warns event organizer for any perceived shortcomings and dangers.
- Contestants gives up any claims for damages or other non-pecuniary damage ancillary claims arising in the context of his participation in the above specified obstacle race PREDATOR RACE, as well as compensation for lost profit.
- If contestant is younger than 18 years he can only participate with written consent of their legal guardian, which will be an integral part of this statement. Contestant younger than 15 years can only participate when physically accompanied by his guardian. Competitors or guardian also declare that contestant is not suffering from any serious disease, that has not suffered any health injury that would prevent participation in the race and is not affected by any mental or other disorder that would somehow restrict its participation in the race. By signing, contestant confirms that he is physically and mentally fit to participate on the race with all the obstacles that will be located along the course.

- Contestant also agrees with first aid that organizer will ensure the day of the race, as well as with any medical treatment that needs to be done due to any injuries and without any delay.
- Contestant also declares that there will be many obstacles through the race so organizer can compensate race to fulfill the purpose of the race. The obstacles are unknown until the day of the race so contestants need to follow instructions from the organizer while competing. For their own safety and also for safety of the others. Contestant can be disqualified without any compensation if not following instructions of the organizer. Contestant also cannot destroy hurdles by any means.
- There will be PREDATOR during the race. Predator is a person dressed as a predator to complicate race and to "fight" with contestants with foam weapons. Any physical contact or thus with the Predator is totally prohibited. Contestant can be disqualified without any compensation in case of hurting Predator.
- Contestant also agree that organizer can make, publish and spread any video and audio recordings and use them for execution of the business plan without any compensation.
- Contestant agrees with using of his personal data only for evidence, business and marketing purpose for indefinite period. This agreement can be only canceled in written form at any time. Contestant also agrees with use of his name and last name, facebook profile, place of living and his audio and video records.
- Organizer can unilaterally change the rules or he can cancel this agreement but he need to inform contestants without any delay and also can check compliance during the race and in case of any violation take further authorized steps. Contestant can be disqualified also after the race if there is evidence of violation of the rules.
- Organizer can change the conditions for the race until the day of the race and also can cancel the race 10 days before the competition. These information will appear on web site www.predatorrace.cz or on facebook profil. In case of cancelling the race ticket price will be returned in same form as it was bought.
- Without signing this conditions contestant cannot participate on the race.
